## Violation of the rights to defence in Turkey: New arrests of lawyers

The Union Internationale des Avocats (UIA-International Association of Lawyers) has been informed of the arrest and detention in Istanbul of 9 lawyers at around 6 am this morning. Those lawyers are İrfan Arasan, Ayşe Acinikli, Hüseyin Boğatekin, Şefik Çelik, Adem Çalışçı, Ayşe Başar, Tamer Doğan, Ramazan Demir and Mustafa Ruzgar.

According to the information collected by the UIA, the reason for these arrests has so far not been disclosed to the lawyers by Turkish security forces. These lawyers are all members of the Association of Lawyers for Freedom (Ozgurlukcu Hukukcular Dernegi - OHD). They are representing 46 lawyers prosecuted for their participation in the defence of the leader of the Kurdish Workers Party (PKK), Abdullah Öcalan, and all have been called to appear at a hearing scheduled tomorrow, on the 17<sup>th</sup> of March.

The UIA severely condemns these arrests, which appear to be arbitrary and in violation of the rights of the defense as enshrined in all international and regional human rights instruments ratified by Turkey<sup>1</sup>.

The UIA denounces, once again, the recurrent attacks on Human rights lawyers, stemming from the abusive use of anti-terrorism legislation. It deplors the fact that once again lawyers are systematically identified with their clients or with the cause defended by them. Such assimilation violates the principles protecting the profession<sup>2</sup>.
